ANNUAL TAX LEVY ORDINANCE

An Ordinance levying taxes for all corporate purposes for the VILLAGE OF BELLFLOWER, MCLEAN COUNTY, ILLINOIS, for the fiscal year commencing on the 1st day of May, A.D., 2018 and ending the 30th day of April A.D., 2019.

Whereas, the Mayor and Board of Trustees of the Village of Bellflower, McLean County, Illinois, have heretofore regularly and legally passed the annual appropriation ordinance for said Village for the fiscal year ending April 30, 2019, and which annual appropriation ordinance was legally and dully published as provided by law more than ten (10) days prior here to, and which appropriation ordinances is by reference made a part of this ordinance.

BE IT ORDAINED BY THE MAYOR AND BOARD OF TRUSTEES OF THE VILLAGE OF BELLFLOWER, MCLEAN COUNTY, ILLINOIS:
